What personal information we collect and why we collect it

When you access this website, information of a general nature is automatically collected. This information is collected in the server log file and includes the type of web browser, the operating system used, the domain name of your internet service provider, your IP address and the like.

This is done for the following reasons:

- To ensure that the website connection is established without any problems
- To ensure the smooth use of our website
- Evaluation of system security and stability

- Processing for marketing purposes (e.g. customer satisfaction surveys)

Storage period

Embedded YouTube videos

When you visit a page with the YouTube plugin, a connection to YouTube servers is established. This tells YouTube which pages you are visiting. If you are logged into your YouTube account, YouTube can assign your surfing behaviour. You can prevent this by logging out of your YouTube account first.

If a YouTube video is started, the provider uses cookies that collect information about user behaviour.
